Minutes of the July 18th, 2016 General Meeting of the Board of Trustees Surfside Office, B-89 7:00 p.m.

President Kriss called the meeting to order at 7:00 p.m.

Community Input: None.

Review and Possible Approval of the June 20th, 2016 General Board Meeting Minutes: After the Board reviewed the June 20th, 2016 General Board Meeting Minutes, Trustee Cahoon moved for approval as presented. Trustee Rowe seconded, and the motion passed unanimously.

<u>Current Bills</u>: Clerk Montana presented check #'s 1225, 1227-1230 for signature in the amount of \$14,044.33 for the final 2015-16 invoice from Surfside Colony Ltd. and July 2016 invoices. Checks were signed as submitted.

<u>Fund Balance and Clerk's Report:</u> Clerk Montana reported the fund balance as of June 30th, 2016 to be \$645,705, and reviewed the trial balance with the Board.

Surfside Colony, Ltd. 2015-2016 Year-End Reconciliation and Final June 2016 Billing: Clerk Montana distributed the fiscal year 2015-2016 year-end reconciliation (see attached) showing total actual expenses incurred by Surfside Colony Ltd. in fulfilling the 2015-2016 Drainage and Erosion Control Contract (excluding rent) of \$66,047, compared to total <u>budgeted</u> expenses for such contract with the District (excluding rent) of \$64,680. Since Annual Contract provided that payments would not exceed budgeted amounts without Board approval, the recurring monthly June 2016 invoice of \$5,940.00 was not adjusted. After review and discussion, a motion was made and carried as follows:

MOTION: Trustee Rowe moved to accept the Surfside Colony, Ltd. 2015-2016 Year-End Reconciliation and Final June 2016 Billing in the amount of \$5,940. Trustee Karich seconded and the motion passed unanimously.

<u>Discussion Regarding Board Member Expiring Terms and Upcoming Election</u>: Clerk Montana reported that John Cahoon, Eugene Salegui and Steve Rowe were up for re-election. John Cahoon reported that he did not intend to run for re-election and President Kriss thanked him for his services on behalf of the Board. Trustee Rowe stated that he would be running for re-election, and Trustee Salegui's decision wasn't known.
