Review and Possible Approval of the September 11th, 2017 General Board Meeting Minutes: After the Board reviewed the September 11th, 2017 General Board Meeting Minutes, Trustee Karich moved for approval as presented. Trustee Garofalo seconded, and the motion passed unanimously.

<u>Current Bills</u>: Clerk Montana presented check #'s 1282-1285 in the amount of \$11,472.79 for October 2017 invoices for monthly drainage and erosion contract, administration expenses, and project costs for review and signature. Checks were signed as submitted.

<u>Fund Balance and Clerk's Report:</u> Clerk Montana reported the fund balance as of October 16th, 2017 to be \$354,435, and reviewed the trial balance with the Board. The Clerk confirmed that the transfer from the LAIF account to the operating account in the amount of \$25,000 approved at last month's meeting had been executed. The Clerk also reviewed the 2017-18 1st Quarter Surfside Colony Ltd. Reconciliation of Expenses with the Board. The difference between amounts paid and expenses incurred was deemed immaterial. The Clerk presented Resolution No. 2017-02 to authorize the District to participate in the Special District Risk Management Authority's (SDRMA) property/liability insurance program.
