<u>Community Input:</u> Karen Johnson of the Community Services District inquired about correspondence received from the Sunset Beach Sanitary District regarding illegal discharge of rain water. Clerk Montana explained that the sanitary district was concerned about elevated levels in the sewer system during recent rainfall, and wanted to determine if any property owners were diverting rainwater into the sewer system, which is prohibited by its ordinance.
