Review and Possible Approval of the March 16th, 2020 General Board Meeting Minutes: After the Board reviewed the March 16th, 2020 General Board Meeting Minutes, Trustee Rowe moved for approval as presented. Secretary Garofalo seconded, and the motion passed unanimously.

Current Bills: Clerk Montana presented check #'s 1378-1381 in the amount of \$34,753.00 for review and signature, consisting of \$24,000.00 for Project Costs as approved at last month's meeting and \$10,753.00 for the monthly Drainage and Erosion billing and general administrative expenses. Checks were approved and signed as presented.

Clerk's Report, Fund Balance and Review of Trial Balance: Clerk Montana reported the fund balance as of April 22nd, 2020 to be \$811,140, and reviewed the trial balance with the Board.
