Community Input: Stacy Taylor, policy manager for Mesa Water District, introduced herself as candidate for the MWDOC, Division 4 seat. She reviewed her qualifications, her advocacy for special districts, and her intentions to ensure economic efficiencies. Board members unanimously agreed to support her candidacy.

Resolution 2020-01 to Adopt FY 2020-21 County of Orange Special District Budget, Cash Reserves, and Investment Policies: After review and discussion, a motion was made and carried as follows:
