Community Input: None.

Review and Possible Approval of the June 15th, 2020 General Board Meeting Minutes: After the Board reviewed the June 15th, 2020 General Board Meeting Minutes, President Kriss moved for approval as presented. Trustee Viets seconded, and the motion passed unanimously.

Review and Possible Acceptance of Surfside Colony Ltd., 2019-20 Year-End Reconciliation of Drainage and Erosion Contract and Final June 2020 Billing: Clerk Montana presented the final 2019-20 year-end reconciliation (see attached) showing total actual expenses incurred by Surfside Colony Ltd. in fulfilling the 2019-20 Drainage and Erosion Contract (excluding rent) of \$78,819.00 compared to total budgeted expenses of \$76,776.00. As the annual contract dated July 2019 specifies that the district may not pay more than total annual contract amount without further board action, after review and discussion, a motion was made and carried as follows:

MOTION: Secretary Garofalo moved to accept the 2019-20 Surfside Colony, Ltd. Drainage and Erosion Year-End Reconciliation as prepared, and to not adjust the final June 2020 payment. Trustee Karich seconded and the motion passed unanimously.

Current Bills: Clerk Montana presented check #'s 1392-1395 in the amount of \$70,284.80 consisting of \$60,789.00 for Project Costs and \$9,495.80 for the monthly Drainage and Erosion billing and general administrative expenses. Checks were approved and signed as presented.

<u>Clerk's Report, Fund Balance and Review of Trial Balance:</u> Clerk Montana reported the fund balance as of June 30th, 2020 to be \$562,633, and reviewed the trial balance with the Board. Clerk Montana distributed the 2019-20 Summary of Finances (Annual Report) for review and distribution at the Annual Surfside Colony, Ltd. Meeting. Lastly, the Clerk reminded everyone that the Candidate Filing Period for the upcoming election is from July 13th through August 7th, and that a Notice of the Upcoming Election had been posted.

<u>Surfside Colony, Ltd. Project Status Update:</u> K.C. Coultrup, Project Manager and Board member of Surfside Colony, Ltd., reported that the engineering survey and plans were being completed for the Drainage Project (Sections 3 and 4). A request for proposals was published, a job walk and bid openings were expected in August, with the project estimated commencement date in September.

<u>Sand Replenishment Project Update:</u> President Kriss reported on recent correspondence with Representative Rouda's office, and that federal funding is still required for the Project.
