Review and Possible Approval of the November 15th, 2021 General Board Meeting Minutes: After Board members reviewed the November 15th, 2021 General Board Meeting Minutes, Trustee Viets moved for approval, Trustee Chamberlain seconded, and the motion passed unanimously.

<u>Surfside Colony, Ltd. Project Update:</u> Clerk Montana distributed the Project Status Template for the A-Row Street Drainage Project, Section 5, indicating that the Project had been completed.
