Review and Possible Approval of the February 20th and March 20th, 2023 General Board Meeting Minutes: After Board members reviewed the Minutes of the February 20th and March 20th, 2023 General Meeting of the Board, Secretary Eric Springer moved for approval, Trustee Chamberlain seconded, and the motion passed unanimously.

Review and Possible Approval of Current Bills Presented: Clerk Montana presented check #'s 1505-1506 for a total amount of \$9,627, consisting of \$8,642 for the April 2023 Drainage and Erosion billing and \$985 for general and administrative expenses. After review and discussion, checks were approved and signed as presented. In addition, Clerk Montana reported that disbursement instructions had been received from the State for payment of the District's share of the Stage 13 Periodic Nourishment Agreement and a check #1504 was issued to the California Department of Parks and Recreation in the amount of \$52,124, per the Board authorization on February 20th, 2023.

Clerk's Report, Fund Balance and Review of Trial Balance: Clerk Montana reported the fund balance as of April 24th, 2023, after payment of the above expenses, to be \$292,239. The Clerk also provided a cash flow projection which indicated a June 30, 2023 ending operating account balance of \$110,216. The Clerk stated that the 2023-24 preliminary budget would be presented at next month's meeting.
